This is why we comply with ISO/IEC 17024:2012 "General requirements for bodies operating certification of persons" as an independent third party.

The cornerstone of our work is the **certification of professional competence**. We objectively certify whether a person meets the requirements to work competently in a given field.

For each specific professional field, the certification schemes establish **minimum competence requirements** that a professional must meet, the adequate training and the types of exams necessary for certification.

To encourage continuous professional development, the certification is not a "one shot" matter.

Certification is valid for a limited time and can be renewed following periodic surveillance in which certified professionals must demonstrate that they have continued to work according to the professional code of conduct and have updated their skills.

This is the way to consistently meet the demands of your clients and the market.

CEPAS-certified training courses involve strict certification and monitoring criteria and are well respected on the market.

The certification process enables us to determine whether a given course meets the established requirements and objectives.

The process consists of the following steps:

- identification and analysis of training needs
- definition of training requirements
- assessment of the course and whether the training is effective.

These three steps are interconnected: the result of step one is the input for step two, and all the steps are continuously monitored for ongoing improvement.

Each course is subject to **CEPAS** monitoring in the form of periodic documentation and on-site surveillance. These ensure that course quality is consistent and that improvement tools are used over time to better meet training needs.

CEPAS certification objectively guarantees adequate instruction as people learn the necessary skills to distinguish themselves in the market. Always meeting the needs of clients and the market!

This is our approach to product, process and service certification in conformity with ISO/ IEC 17065:2012 "Conformity Asseassment. Requirements for bodies certifying products, processes and services". This standard establishes the requirements that a certification body must complies to operate competently, consistently and impartially.

When **CEPAS** certifies a product, process or service, it states, in accordance with clear, transparent rules, that those product, process or service provided by an organization meet the requirements of a certain standard.

The certification process follows strict procedures and requirements for competence, independence and objectivity. This establishes whether the service complies with the certification scheme.

The process is part of a virtuous cycle and generates added value for all market stakeholders: the service provider gains a competitive edge and clients gain a service quality guarantee.

Since 1996, **CEPAS** has been accredited by ACCREDIA, the national accreditation body recognized by the Italian government.

CEPAS is accredited as a People Certification Body in conformity to UNI CEI EN ISO/IEC 17024:2012 (Certificate No. 031C) and as a Product Certification Body in conformity to UNI CEI EN ISO/IEC 17065:2012 (Certificate No. 152B).

Accreditation of certification bodies guarantees the following fundamental values:

- **Impartiality**, because all concerned parties receive fair and equal consideration
- Independence, because the certification body guarantees that there are no conflicts of interest with the people and organizations requesting certification
- **Compliance**, because complying with European standards requires that professionals are certified by independent third parties according to generally accepted (mandatory or voluntary) rules
- **Competence**, because people responsible for the assessment are qualified professionals.
